3 **AMENDING CHAPTER 12 OF THE DANE COUNTY CODE OF ORDINANCES,**  
4 **REGARDING ZONING FEES**

6 The County Board of Supervisors of the County of Dane does ordain as follows:

8 **ARTICLE 1.** Unless otherwise expressly stated herein, all references to section  
9 and chapter numbers are to those of the Dane County Code of Ordinances.

11 **ARTICLE 2.** Section 12.08 is amended to read as follows:

12 **12.08 SIGN PERMIT FEES.**

13 ~~(1) Permits are required for the installation, erection or alteration of the types of~~  
14 ~~signs listed below. The repainting, changing of parts, and preventive~~  
15 ~~maintenance of signs which completely conform to the requirements of Chapter~~  
16 ~~40 shall not be deemed alterations requiring a sign permit. Zoning permits are~~  
17 ~~required for the installation, erection, replacement, or reconstruction of a sign.~~

19 (2) Zoning permit for a sign. Application review fees. Fees are imposed according  
20 to the following schedule:
