Brian,

I reached out to LTSB and they confirmed that they just received notice from the Census of the delay, stating:

The Redistricting Data will be delivered to official state recipients **after** July 31, 2021. We continue to work on the redistricting data schedule and will provide more precise delivery dates within the coming weeks.

Local redistricting could not start until at least August 1. However, they advised that Wisconsin has historically not been one of the first to receive the data, generally in the middle of the pack. So, the start data would likely be even later. The LTSB is working on a communication to municipalities and counties. Other than the start date being delayed I don't see it changing the designated time period for each phase of the redistricting process.
