The Collaborative Stabilization Coalition (CSC) of Greater Dane County offers free online training to direct caregivers of people living with dementia and intellectual/development disabilities (I/DD) with focus on crisis prevention and person-centered planning. Due to COVID-19, the face-to-face training format was changed to virtual instructor-led trainings using Zoom.

The CSC team would work with ERI to achieve the following training goals:

- 1. Provide training and technical assistance to CSC presenters on adapting training content for use in virtual online trainings using Zoom, managing live, virtual events and engaging learners in a virtual environment.
- 2. Develop a cohesive design for training materials (powerpoints, handouts, etc.) and update materials to incorporate these new design standards.
- 3. Build individual asynchronous self-paced, online versions of the CSC trainings to expand training opportunities, increase learner access, and facilitate training sustainability.
