## Corporation Counsel

### *Guardianship Fees (Dyann Hafner)*

*Hafner presented to the committee on Guardianship Fees, and explained that Dane County Ordinance 62.14 authorizes the collection of such fees. Sparkman asked whether the County pays the guardianship fees, and Hafner confirmed there have been cases where the County does pay. Baring asked whether such fees would apply to juveniles, and Hafner answered she did not believe so. Wegleitner asked about the history of the statute that authorized such fees, and Hafner explained. Bayrd asked whether a Ward's Estate ever had difficulties in remitting the fees.*

### *Child Support Fees (Vue Yang and Lisa Bina)*

*Bina presented to the committee on various fees related to child support services. A copy of the presentation is attached to these minutes. Sparkman asked whether the State Disbursement fee was sufficient to cover the costs associated with the state disbursement fee. Bina informed him that the fees did not cover the costs. Wegleitner asked about the fee totals related to the genetic testing. Yang explained the amount. Baring and Ketchum asked about the enforcement mechanisms used to collect past child support, and Yang and Lisa explained. Ketchum asked whether Child Support had data to determine how many individuals with child support orders are under state supervision, and Yang explained the agency did not. Wegleitner asked about potential modification efforts of those orders where the parent may need additional assistance.*
