BATTERMAN shared the work plan, noting many strategies were cancelled due to COVID-19.

2. 2021 Aging Advocacy Day

OLSON reported a lot of discussion but nothing is set up yet.

3. 2022 AAA Budget Priorities

BATTERMAN stated discussions with POS agencies will be extremely important this year as the 2022 budget is expected to be extremely tight.

AAA Aging Program Specialist, Angela Velasquez expressed concerns about funding for the meal program in 2022. In addition to the anticipated increase in the number of meals, catering costs are expected to also increase.

4. ADRC Governing Board

OLSON reported that Dane County Human Services Director Shawn Tessman spoke to the Board about the mission statement and strategies for the future. OLSON commented that she was very happy with the programing that TESSMAN was able to preserve for this fiscal year however the next coming years will be very difficult.

County/State/Federal Legislative Update

Dane County Lobbyist Carrie Springer reported the state legislature is back in session. The Federal government is under new Administration and a top priority is vaccines. FEMA is being looked at to assist with distribution but at the moment there is not enough of the vaccine to get out to selected Tier 1a people.

State's Aging Advisory Council

OLSON advised the Council is still trying to meet quarterly with a meeting in February 2021.

8. Chair & Staff Reports

BATTERMAN reported on her efforts to email daily COVID-19: Dane County Aging Network Status reports. There is much concern to fund and coordinate rides for older adults to obtain vaccines throughout Dane County. The DCDHS Transportation Call Center does not have funding or staffing to handle these additional transportation requests. RSVP started a pilot program to train 10 volunteer drivers to help with this and are in the process of bringing on 10 more to help fill the need. BATTERMAN is discussing transportation needs with ACS Administrator Todd Campbell and Transportation Coordinator Jane Betzig to find an immediate solution. The Cultural Diversity program has limited funding to help with vaccine transportation costs for African American, Black, and Latinx older adults living outside of Madison.

The Dane County three year aging plan's draft is due in June and will be taking a lot of time to put together the reporting requirements during a pandemic.

NewBridge hired a new Dietitian, Shannon Gabriel, who will be starting at AAA on February 1, 2021.

VELASQUEZ shared that by connecting with KinshipCare program in December, there has been an increase in grandparents of color receiving caregiver grants.
