Hi Brian!

Keith and Kristin might have more to contribute here than I do, since they've done this before. This is my first redistricting cycle, but I'll tell you what I can.

To my knowledge, Idaho doesn't have a formal grading/evaluation system for maps submitted by the public. (Kristin and Keith can correct me here if I'm wrong.) But my guess is that the Commission will consider and evaluate all publicly-submitted maps according to how well they conform to Idaho's required redistricting criteria, which you can review <u>here</u>. Of those criteria, probably the most important one (besides population) is how effective the map is at avoiding county divisions, since our Supreme Court views county splits very unfavorably (unless they're absolutely necessary, which they are in a few of the more populous counties).

So I guess my best advice is to review any Wisconsin case law on redistricting, see if there are certain criteria that your courts *really* emphasize, and weight those criteria heavily in your evaluation process.
