Our commissions are still in the process of being selected, but when they convene, they will draft and adopt policies and procedures for evaluating and scoring maps. The software solution we are using for drawing maps, <a href="https://www.esri.com/en-us/arcgis/products/esri-redistricting/overview">https://www.esri.com/en-us/arcgis/products/esri-redistricting/overview</a>, can be programmed to evaluate maps according to whatever criteria is required or desired, so we will likely rely heavily on that.
