Hi Brian, thank you for the email. As we evaluate maps for our map-drawing competitions, we were careful to not pre-select any values that mattered more than others or would emphasize in judging. (Beyond what is constitutional, of course.) And ultimately, when the mapping actually starts, we aren't going to be advancing any particular map as the "best map." So it's a bit of a different goal than what you all are looking to do. But, I'm happy to share our judging rubric in case that is helpful. About halfway down on this webpage, there is a heading titled "Judging Criteria" and the next few sections go over this.

The maps that did the best in our competitions were the ones that accomplished the goals they set out to accomplish (mappers had to <u>declare which value</u> they were emphasizing in their map), and also drew a balance with the other values.

But ultimately, our view is that the input from the public is going to be the most important value that they want to emphasize in the maps that are chosen by the state or locality.
