APPROVAL OF THE CDBG-CV FUNDING RECOMMENDATIONS DCDHS – HAA DIVISION

6 Dane County is an Entitlement Community under two U.S. Department of Housing and Urban 7 Development (HUD) programs: the Community Development Block Grant (CDBG) and the Home 8 Investment Partnerships (HOME). CDBG funds are intended to develop viable urban 9 communities by providing decent housing and a suitable living environment, and by expanding 10 economic opportunities, principally for low-and-moderate income persons. The intent of the 11 HOME Program is to expand the supply of decent, safe, sanitary and affordable housing, with 12 primary attention to rental housing for very low-income and low-income families.

In response to the COVID-19 pandemic, Congress provided an additional allocation of CDBG
funds to communities be used on eligible CDBG activities that prevent and respond to the spread

of COVID-19 (CDBG-CV). Dane County received a total of \$2,077,835.26 in CDBG-CV funds
from the three rounds of CARES Act funding.

17 The County established a competitive application process for the allocation of CDBG-CV grant

18 funds. Applications were solicited beginning October 7, 2020 and due November 19, 2020. The

Application Review Team, a subcommittee of the CDBG Commission, met on January 19 and 20,

20 2021 to hear presentations by the applicants and to make initial recommendations to the full

21 CDBG Commission. The CDBG Commission made its preliminary recommendations at its

22 January 26, 2021 meeting.
