Presentations by Community Organizations: Walter Williams, Charles Hamilton Institute; Linda Ketchum, Just Dane; Karen Reece, Nehemiah; Peng Her, Hmong Institute; Alex Booker, Urban Triage; Evelyn Cruz, Centro Hispano.

Community organization representatives met with focus groups comprised of community members regarding interest, expectations, and goals of a community justice center. Community organization representatives share feedback from community members. Common themes include hope in the potential of a community justice center, but some hesitation and distrust of the criminal justice system. Community members hope that stakeholders are fully invested and engaged in this model, and see it as an opportunity to reestablish trust and create additional supports within the justice system.

Discussion ensued with Criminal Justice Council (CJC) members and community organization representatives regarding establishing trust, investing in community, and cultural competency.

2. COVID-19 in Confined Spaces Update

Presented by Professor John Eason, University of Wisconsin – Madison Presentation attached

Professor John Eason, Justice Lab, discussed findings in jail population and flattening the curve of COVID-19 spread within the jail facility. Joined by Malia Jones, PhD, discussion ensued around the reduction in exposure to COVID-19 due to jail population reduction.

3. PHMDC: Violence Prevention Plan
