Policy Analysis Statement:

Brief Description of Proposal -The Wisconsin Department of Transportation (DOT) is providing \$69,035 funding to the Sheriff's Office for the Flex-Lane Beltline Project for planning, coordination and staffing services to mitigate traffic incidents and speeding on USH 12 between Whitney Way and IH 39/90 for the period April I, 2021 through December 31, 2021. The Sheriff's Office shall provide dedicated patrol coverage in the project work-zone to ensure safety and mobility of the traveling public. DOT shall reimburse Sheriff's Office for actual hourly overtime including benefits, mileage, and administrative support staff costs.

Current Policy or Practice -

Authorization of contracts including budget amendments must be approved by the County Board.

Impact of Adopting Proposal -

The Sheriff's Office is committed to promoting safety for the traveling public and workers during road construction and maintenance activities performed on Wisconsin's highway network. Managing traffic is a continuous process that requires monitoring and updating as traffic flow and construction scheduling changes. Effective deployment of traffic enforcement strategies in work zones on high-speed highways greatly improves traffic safety and saves lives.
