- Total appropriation of \$1.9 trillion.
- Signed into Law on March 11, 2021.
- Many provisions affecting individuals, businesses, governments, and educational institutions.

- Key provisions for individuals
 - Extends enhanced unemployment benefits of \$300/week until September 6, 2021.
 - Provides direct payments of \$1,400 to most Americans.
 - Provides a refundable child tax credit of up to \$3,600 per child.
 - Extends a 15% increase in SNAP benefits.

- Key provisions for businesses
 - \$28.6 Billion for assistance to restaurants and bars.
 - \$7 Billion for the Paycheck Protection Program that expires May 31, 2021. The ARP did not extend the end date.
 - \$1.25 Billion of additional funding for the Shuttered Venue Program.

- Key provisions for education institutions and governments.
 - \$130 Billion to support K-12 education
 - \$40 Billion for higher education
 - \$156 Billion for Federal Emergency Management Agency and federal, state and local public health expenses.
 - \$26 Billion for housing initiatives.
 - \$21.6 Billion for emergency rental assistance.
 - \$350 Billion for state and local governments.

- Key provisions for Dane County
 - \$106.3 million from the State and Local Relief Fund
 - \$7 million estimated of additional Emergency Rental Assistance
- Emergency Rental Assistance funding will allow for continuation and expansion of rental payments to households impacted by the pandemic.

- State and Local Relief Fund Uses:
 - To respond to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19) or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality;
 - To respond to workers performing essential work during the COVID— 19 public health emergency by providing premium pay to eligible workers of the county that are performing such essential work, or by providing grants to eligible employers that have eligible workers who perform essential work;

- For the provision of government services to the extent of the reduction in revenue of the county due to the COVID-19 public health emergency relative to revenues collected in the most recent full fiscal year of the county prior to the emergency;
- To make necessary investments in water, sewer, or broadband infrastructure.

- County will receive one payment of \$53.3 million by May 11, 2021 and the balance 12 months later.
- Specific guidance from Treasury will be released in early May.
- All local governments in the State of Wisconsin will receive funding.
 - City of Madison \$49.19, Sun Prairie \$3.43, Fitchburg \$3.04,
 Middleton \$1.98, Waunakee \$1.39, Verona \$1.31, Stoughton \$1.3,
 DeForest \$1.06, Oregon \$1.04. Total among all cities, villages and towns is \$77.56 million.
- Spending period extends to December 31, 2024.

- Emergency Still Exists
 - Dane Buy Local received over \$50 million in applications for its most recent round of \$4 million in funding.
 - Tenant Resource Center received over 8,000 applications for past due rent in March.
 - As of February 2021, there are over 24,000 fewer persons employied in the Madison Metro area than in February 2020.

- Allocation Plan Developed by the Administration:
 - Conform to the stated purposes of the legislation: assisting individuals, businesses and non-profits
 - Continue to meet emergency needs with community partners.
 - Incorporate priorities of the County Board as expressed in standing committee meetings and public hearing held by Personnel and Finance in July 2020.
 - Provide financial stability to county operations to protect existing services and county workers.
