- 1. Kiefer will work with the Middle School Principal to solicit unit name suggestions from students and incorporate education about the site into the curriculum.
- 2. Each of the names should have a short write-up regarding how the name was selected.
- 3. Suggestions will be vetted Park Commission Chair and Staff and ~2-5 suggestions will be shared with the Commission to see if there are any objections.
- 4. Middle school students will vote on names from the approved list.
- 5. Request that the student(s) who suggested the final unit name present at the Parks Commission and see the Commission approve the name selected by the Middle School students.
