SECOND LEASE EXTENSION OF DANE COUNTY SHERIFF SOUTHEAST PRECINCT LEASE WITH TOWN OF PLEASANT SPRINGS

Brief Description of Proposal -

Request authorization to extend the Southeast Precinct lease with the Town of Pleasant Springs an additional six months through December 31, 2021. The terms and conditions of the current lease, including rent of \$4,875 per quarter shall remain the same.

Current Policy or Practice -

The Southeast Precinct had planned to relocate to a new space this spring, but construction on the new space has been delayed and is anticipated to be finished this fall. The Town of Pleasant Springs has agreed to extend the lease six months, through December 31, 2021, in order to accommodate the county's move.

Impact of Adopting Proposal -

Extension of the existing lease is required to accommodate construction delays that have occurred that affect the completion date of the new Southeast Precinct.
