AUTHORIZING EXECUTION OF A LEASE OF AGRICULTURAL LAND AT THE DANE COUNTY REGIONAL AIRPORT

Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Regional Airport has negotiated a lease with Uphoff Company, Inc. involving two parcels of vacant land in the vicinity of the Dane County Regional Airport, totaling 72.66 acres. The lease covers five growing seasons, expiring December 31, 2025. The lease requires that the land be planted in soybean or corn crops, and continues the requirement that soil erosion and nutrient runoff be minimized and requires the use of plowing practices to minimize potential attractants to wildlife that may be hazardous to airport operations.

Current Policy or Practice -

Land that surrounds the airfield at Dane County Regional Airport is leased to Uphoff Company, Inc. for agricultural use to ge nerate revenue. Specific plowing practices are used to minimize attractants to wildlife that may be hazardous to airport operations.

Impact of Adopting Proposal -

Agricultural land on airport property will continue to generate revenue in a manner consistent with airfield and aircraft saf ety.
