## E. Reports to Committee

1. LIO 2021 Budget Update - Mueller

*Mueller presented the 2021 LIO Adopted Budget. He reports that the only change from the 2021 LIO requested budget submitted to the County Executive was a modification to the Indirect Costs expenditure account made by the Budget Office. The Register of Deeds department recording volume has resulted in a surplus in revenue for this year. With the 2020 budget assuming 80,000 Register of Deeds recorded documents for the year, the office has recorded 103,000+ documents by November 1, 2020. Mueller also made note that the Conferences and Training has been primarily virtual this year, resulting in savings. The LIO is in a good position from a fund balance perspective for the end of 2020.*

2. Fly Dane 2020 Update - lausly

*Fly Dane 2020 is anticipated to be completed in approximately 3 weeks. Currently the 6' imagery is loaded on the network and available internally for County staff. A discrepancy in the ESRI server application was denoted recently which shifted imagery and lausly has initiated an immediate investigation and remedy by ESRI.*

3. WLIP Strategic Initiative Grant Program 2021 - lausly

*The 2021 WLIP grant program will be fully funded, a result of the recording volume currently being experienced by Register of Deeds offices. lausly reports he will be submitting an application in the near future, and that the criteria is unchanged from the past. The Department of Military Affairs has submitted to the Governor's budget a grant proposal to assist with Next Gen 911 implementation. More information forthcoming in future meetings.*

#### 4. PLSS Remonumentation and Parcel Mapping Project - Frick & Everson

*Frick provided an update on the status of the PLSS Re-mon Project. Next steps in the RFP process are the Towns of Deerfield, Medina, and York. Everson pointed out that the re-mapping process is following behind the re-mon work and there may be irregular mapping at the edge lines of those towns that are complete and published.*
