Well, AB 369 was introduced and had a hearing and exec today already. It looks like they did send a notice out late last week. The tracking system from Wheeler makes it look like it was today, but they did send it out late Thursday afternoon. Sorry for the confusion. They scheduled a hearing for today at 1pm and it has already passed the committee on a 9-3 vote. I'm guessing it was a partisan vote. The author listed for the bill is the committee. Here is what it says about the county timeline:

This bill does all of the following with respect to the local redistricting timeline

following the 2020 federal decennial census:

1. Provides that counties have until February 22, 2022, to adopt tentative county supervisory district plans based on the 2020 federal decennial census.
