Data Review and Analysis

### • MAY – PRESENT QUALITATIVE AND QUANTITATIVE DATA ANALYSIS TO INFORM THE NEEDS ASSESSMENT

- Reviewing aggregate adult criminal justice data for the years 2015 through 2020
- Youth justice data and trend data will be shared as available
- Qualitative data /reports obtained from the initial preengagement events with the 7 community groups
- Data sources: Dane County CJC Research and Innovation Team and other relevant data providers, such as youth justice stakeholders of Dane County and other sources identified during the needs assessment, as available.
- Additional data provided by CJ stakeholders after interviews

## IN PROCESS

Data Review and Analysis

#### • MAY – PRESENT

#### QUALITATIVE AND QUANTITATIVE DATA ANALYSIS TO INFORM THE NEEDS ASSESSMENT

- The vendor will use this data to answer the following questions, among others:
  - What are the ongoing needs in the Dane County criminal justice system, as demonstrated by the aggregate data, that could be better met by restorative justice practices and policies?
  - How would the establishment of a Community Justice Center (with or without a community court incorporated into the center) help Dane County to better meet the needs demonstrated by the data and qualitative findings?
  - What should be the key attributes of a Dane County Community Justice Center?
  - What is the array of services that should be provided?
  - Should a community court be included? Advantages and disadvantages? What are the impacts on racial equity, procedural fairness, and public safety outcomes?
  - What are the costs and what are potential outside sources of funding?
  - What are the facility and space needs?

# IN PROCESS

Best Practices and Models Research

#### • MAY → PRESENT BEST PRACTICES/MODELS COMPARATIVE ANALYSIS AND RECOMMENDATIONS

- CCI will conduct a comprehensive inventory and analysis of a broad list of relevant community justice center models and their distinguishing features to include in final report recommendations
  - Consider local resources, needs, and priorities revealed throughout the needs assessment, and illustrate how these various models could meet the needs identified by both the public engagement process and the aggregate data.
  - Identify the various resources, funding needed to implement the recommendations
  - Advise on planning process(es) most appropriate for Dane County, including approaches for employing short-, mid-, and long-term goals, objectives, and action items.
