# DANE COUNTY CONDITIONAL USE PERMIT #2521

THE ZONING AND LAND REGULATION COMMITTEE OF THE DANE COUNTY BOARD PURSUANT TO SECTION 10.101(7) OF THE DANE COUNTY CODE OF ORDINANCES DOES HEREBY:

GRANTS Conditional Use Permit # 2521 for construction of a residential accessory building up to 16 feet tall in the SFR-08 district conditioned upon Dane County Code of Ordinances Section 10.101(7)(d) and subject to the additional conditions listed below:

**EFFECTIVE DATE OF PERMIT: June 22, 2021** 

THE CONDITIONAL USE SHALL BE LOCATED ON THE PROPERTY DESCRIBED AS FOLLOWS:

LOCATION: 7979 Stagecoach Road, Town of Cross Plains

#### Legal Description:

Lot 70, Plat of Oak Valley Estates, located in section 1 of the town of Cross Plains, Dane County, Wisconsin.

#### **CONDITIONS:**

1) The residential accessory building shall be used for residential storage purposes only. The accessory building shall not be used for living space (DCCO 10.102(2)). Plumbing fixtures inside the accessory building are prohibited.

## THE ZONING AND LAND REGULATION COMMITTEE AFTER PUBLIC HEARING AND IN THEIR CONSIDERATION OF THE CONDITIONAL USE PERMIT MADE THE FOLLOWING FINDINGS OF FACT:

- 1. That the establishment, maintenance and operation of the proposed conditional use will not be detrimental to or endanger the public health, safety, morals comfort or general welfare.
- 2. That the uses, values, and enjoyment of other property in the neighborhood for purposes already permitted will not be substantially impaired or diminished by the establishment, maintenance, and operation of the proposed conditional use.
- 3. That the establishment of the proposed conditional use will not impede the normal and orderly development and improvement of the surrounding property for uses permitted in the district.
- 4. That adequate utilities, access roads, drainage and other necessary site improvements will be made.
- 5. That adequate measures will be taken to provide ingress and egress so designed as to minimize traffic congestion in the public streets.
- 6. That the proposed conditional use does conform to all applicable regulations of the district in which it is proposed to be located.
- 7. The proposed conditional use is consistent with adopted Town and County Comprehensive Plans.
- 8. If located in the Farmland Preservation (FP) area, the conditional use meets the necessary findings to be located in the district as per Dane County Code of Ordinances Section 10.220 (1).

#### **EXPIRATION OF PERMIT**

Upon the allowed land use's cessation or abandonment for a period of one year, this conditional use permit will be deemed to have been terminated and any future use shall be in conformity with the ordinance.
