These amendments establish, consolidate, and clarify the provisions of Chapters 2, 67, and 68 of the Dane County Code of Ordinances related to minimum standards under which fueling operations are conducted at the Dane County Regional Airport.

# Current Policy or Practice -

Currently the ordinance provisions addressing the minimum standards for aircraft fueling operations at the Airport are somewhat dated and are dispersed among sections of Chapter 67 and Chapter 68, with related terms of enforcement found in various sections of Chapter 2.

# Impact of Adopting Proposal -

This ordinance amendment updates current aircraft fueling standards, deletes the present standards from Chapter 67, consolidates the revised regulations in a single section of Chapter 68, and amends the enforcement provisions in Chapter 2 to conform to the revised standards.
