# DISCUSSION AND COMMITTEE ACTION ON ADDITIONAL PROGRAM EVALUATION TOPIC PROPOSALS

Staff gave update on progress of Parks and Zoo Equity and Access program evaluation process (RFP is being drafted). Sup. Bayrd gave an update on conversations with municipal court judges regarding a study. They determined a program evaluation of municipal court functions and programming is not necessary and will work through other channels. Sup. Bayrd mentioned possible other ideas raised in PP&J Committee, but has no proposals at this time.

Chair Eicher recommended a program evaluation topic: It would build on the jail stress test and other jail analytics performed by the JFA Institute for Dane County. This study would utilize data to identify drivers of incarceration in Dane County, review classifications, provide additional training for the new jail population manager, analyze reductions in length of stay, etc.

Looking for an opportunity to continue the benefits of the jail population reductions during the pandemic.

Sup Chawla would also like best practices recommendations/guidance for jail census data on a daily basis rather than as a snapshot in time.

The Committee directed staff to move forward with drafting and executing a single-source contract with JFA Institute for this topic (with funding out of program evaluation line). The project will be run in two phases, with the first phase completed in 90 days--September 2021.

## UPDATE AND CONTINUING DISCUSSION OF RETURN TO OFFICE AND IN-PERSON MEETINGS

Peterson-Thurlow gave an update and indicated that staff are working with DIM to upgrade technology to allow for hybrid meetings. Tech upgrades will be completed in September and training of county department staff will need to occur. Also will discuss board room security with the City-County Liaison Committee.

Supervisor Kiefer spoke to the committee regarding the County Board's return to in-person meetings:

- 1) He requests that a Dane County Sheriff's deputy be present at in-person County Board meetings.
- 2) He supports a return to in-person meetings as soon as possible.

DeGarmo: Likes the hybrid meeting option for the future. Worried about having uniformed officers in the meeting because of possible effects on other people attending the meeting.
