Provide a detailed explanation as to why the competitive bidding (RFB/RFP) process cannot be used. Also provide a detailed justification in relation to the Procurement Exception chosen:

Dane County Department of Waste & Renewables (W&R) owns and operates a Renewable Natural Gas (RNG) Plant that converts landfill gas (LFG) to pipeline quality RNG that is injected into the interstate transmission pipeline. As part of the cleaning process, the H2S needs to be removed from the LFG.

The vendor will supply two mobile container vessels to pretreat the LFG for H2S. In 2020 the Department of Waste & Renewables previously purchased 2 of the vendor's mobile vessels as a temporary pre-treatment system for the LFG.

The vessels provided reliable processing capacity for the removal of H2S from the LFG during maintenance of the primary H2S removal system and also allows for additional capacity to effectively manage seasonal surges in H2S.

The Department is requesting to purchase 2 more to expand/supplement the existing system. The new vessels have the option to be installed in sequence with the existing vessels and procurement of compatible vessels is necessary to allow for efficient transmission of the LFG through the vessels.
