Brief Description of Proposal -

The US Department of Justice, National Criminal History Improvement Grant Program, and the Wisconsin Department of Justice are making funds available for participation in the 2021 Livescan Machine Replacement Program, Grant Number 2020-NC-01-16648; grant project period is August 1, 2021 February 28, 2022. Grant funding shall provide for the replacement of two Sheriff's Office automated fingerprint recognition systems, Livescan machines.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

Impact of Adopting Proposal -

Sheriff's Office Livescan fingerprint systems, purchased in 2005 and 2013, are obsolete and require replacement. Fingerprinting is used to determine an individual's identity, to track records of criminal actions such as arrests and dispositions, to process inmates, both adults and juveniles, into the justice system, to provide DNA collection services, and for background checks for employees, program volunteers, and individuals who require jail access.
