#### Brief Description of Proposal -

The Dane County Department of Human Services – Housing Access and Affordability Division (HAA) seeks to contract with Focus Counseling to continue non-congregate isolation and quarantine shelter for people experiencing homelessness who are symptomatic/positive for COVID-19 or a close contact for a positive COVID-19 case. HAA also seeks to contract with Focus Counseling to continue non-congregate shelter for people experiencing homelessness who are at higher risk of severe illness if they contract COVID-19. Focus Counseling has provided services for both programs since Dane County's COVID-19 response began. The funding source for the program is changing from CARES to ARP.

Current Policy or Practice -

Major contracts require Board approval.

Impact of Adopting Proposal -

A major contract will be awarded to Focus Counseling in the amount of \$1,651,991.
