Pursuant to Section 10.101(9) of the Dane County Ordinances, Appellant Yahara

Materials, Inc. ("Yahara"), by its attorneys Husch Blackwell LLP, hereby gives notice of appeal

and appeals a decision of Daniel Everson, Dane County Assistant Zoning Administrator

("Assistant Zoning Administrator"), which was dated March 9, 2020 (the "Decision"). In the

Decision, a copy of which is attached hereto as **Exhibit A**, the Assistant Zoning Administrator

erroneously determined that Tax Parcels 0508-324-9000-5 and 0508-323-9500-1 (collectively,

the "Krueger Site") are not considered legally nonconforming for non-metallic mineral

extraction. The property owner of the Krueger Site, the John L and Josephine A Krueger Trust

(the "Trust"), leases the Krueger Site to Yahara for use in its non-metallic mineral extraction

operations. Yahara makes this appeal as an authorized agent for the Trust.

For the reasons set forth in the attached letter to Dane County Zoning Administrator Roger Lane on April 2, 2020 (Exhibit B), and based on the evidence to be submitted at a hearing in this matter, the Dane County Board of Adjustment should find that the Assistant Zoning Administrator's Decision is in error and, pursuant to its authority contained in Dane Co. Ordinance § 10.101(9)(e), reverse that Decision and determine that the Krueger Site is, in its entirety, nonconforming for mineral extraction. Appellant and the Trust are aggrieved by the Decision, because it deprives them of their use of the Krueger Site and impairs their ability to generate income therefrom.
