Commission members continued discussing 2022 Budget Recommendations. John Reimer presented financial costs associated with Aquatic Plant Harvesting Options.

A motion was made by WEST, seconded by LEVIN, that the 2022 Budget Recommendations include increasing aquatic plant harvesting operations from 8 to 10 hour shifts, 5 days a week, and additional funding of \$98,530 for a Full Time Mechanic and \$55,320 for operating expenses.
