AMENDING CHAPTER 62 OF THE DANE COUNTY CODE OF ORDINANCES, ELIMINATING CERTAIN FEES FOR TIER I FAMILIES

Policy Analysis Statement:

Brief Description of Proposal -

This amendment eliminates certain Family Court Counseling fees for parties with combined annual gross incomes of both households of less than \$60,000

Current Policy or Practice -

Families are charged \$500 for custody studies and \$300 for brief focused assessments.

Impact of Adopting Proposal -

Fees for these services would be eliminated for families with combined gross incomes of less than \$60,000.
