A motion was made by Vice Chair Klehr to approve the November 11, 2022
Commission meeting minutes, seconded by Commissioner Miquelon.

C. Presentations

1. Maria Amalia Wood, 2022 Cycle 2 Dane Arts Grant Recipient, Remendando Memorias

- *Maria Amalia uses art as a tool to build community, find common ground, and create a space where difficult conversations around inclusivity, equity and diversity can be approached.*
- *The name of the project, "Remendando Memorias" (mending memories) has been changed to "Bordando Memorias" (embroidering memories).*
- *Bordando Memorias takes place at Synergy Coworking with support from the Madison Arts Commission and Madison Public Library.*
- *Participants of the project will embroider self-portraits surrounded by flowers native to Wisconsin and country of birth.*
- *Madison Public Library has funded commissioned tables for this specific project after which they will be used at various public libraries.*

D. Action Items

1. Youth Art Equity Proposal Presented by Supervisor Xistris-Songpanya

- *The County Board of Supervisors has secured a \$40,000 grant included in the County Executive budget for arts programming that provides equitable opportunities for under served youth to participate.*
- *It is recommended by the Executive Committee that the \$40,000 grant be added to the 2023 grant cycle, similar to the Blockstein award.*
- *There is a question in the 2023 Cycle 1 grant application that states: "Is your project providing equitable opportunities for youth to participate?"*
- *How the funds will be distributed in each cycle is still to be determined.*
- *Commissioner Curet will investigate how the \$40,000 award will be included in fund allocation formula.*

A motion was made by Commissioner Puleo Moyer to accept the \$40,000 allocated by the Dane County Board for art programs that assist under served youth in the Dane County community, seconded by Commissioner Garret.

The motion was carried unanimously by a voice vote.

2. Funding Admission-Free Events, led by Chair Ritcherson

- Chair Ritcherson articulated that the mission of the Dane Arts Commission is to ensure that participation in the arts is equitable and available to all.
- Chair Ritcherson proposed that Dane Arts funds are allocated toward free performances within an organization, even if they have other paid programming. This is not to say an organization cannot have paid programming or that artists are not paid. Rather, if an applicant has a free performance built into their application, Dane Arts funds shall be distributed to the free performance specifically.
- Commissioner Parks Snider suggested an additional monetary incentive for no-admission events.
- Commissioner Puleo Moyer suggested that Dane Arts could be mentioned as a supporter of admission-free events specifically.
- Director Fraire recommended maintaining the existing grant process until additional funds are raised, and ensuring all grant recipients give appropriate credit to Dane Arts.
- Due to time constraints and lack of consensus, the discussion on admission-free events was paused.

E. Reports to Committee

1. Chair/Executive Committee Report

- The next discussion during the February Commission meeting will be youth engagement led by Vice Chair Klehr and Commissioner Parks Snider and general information about the upcoming grant cycle.
- Commissioner Parks Snider and Commissioner Curet, whose current terms expire in June 2023, have agreed to serve another term on the Dane Arts Commission.
- Once Kelsey Yudice and Jay Handy are confirmed by the County Executive, the commission will be fully staffed.
- Going forward, all public meetings must be held in a hybrid format which means that Dane Arts staff and the Chair or Vice Chair must be present in person.
- Chair Ritcherson does not expect all commissioners to attend in-person.

2. Area of Focus Discussion/Reports

- Chair Ritcherson requested that each commissioner identify an area of focus and report what they will be working on during the February commission meeting.
- Commissioner Garret requested to be included in the Public Relations area of focus.
- Commissioner Gallagher would like to work with Jay Handy (once appointed) on fundraising and possibly marketing.
- An area of focus that is not listed is policy and procedures, which Vice Chair Klehr oversees.
- Additional areas of focus that warrant further discussion are a fund advisory committee, and volunteer recruitment/Friends of Dane Arts group.
- All commissioners are encouraged to be involved in commissioner brainstorming and recruitment.
