### 1. Agency Updates

AMY SCARR- PLANNING FOR WORLD ELDER ABUSE WORLD DAY JUNE 15TH CCR STILL CONTINUE TO MEET. MPD MENTAL HEALTH PROGRAM OFFICER DOES PRESENTATIONS. FINANCIAL ABUSE SPECIALIST TEAM MEET MONTHLY. NOV 1ST CONFERENCE FOR UNDERSTANDING SAFETY PLANNING PROCESS.

BETH FREEMAN- HIRING INTAKE SPECIALIST FOR HELP LINE. ALLOWING HOSPITALS TO NAME PATIENT REPRESENTATIVES TO ALLOW DISCHARGE WAS NOT PASSED. BILL – ALLOWS FINANCIAL SERVICES PROVIDERS TO PUT A HOLD ON BANK TRANSACTIONS IF THERE IS FINANCIAL EXPLOITATION (SUSPECTED).

SUP PELLEBON- GOING THROUGH LAST 2 COMMUNITY AUDITS TO SEE WHAT HAS NOT BEEN COMPLETED. LAST AUDIT WAS DONE BUT IT WASN'T FOLLOWED UP ON "WE WANT TO WRAP UP WHAT HAS ALREADY BEEN DONE BEFORE STARTING." GOING THROUGH OLDER REPORTS AND IDENTIFYING GAPS THAT EXISTED THEN AND STILL DO NOW. SHOULD BE DONE 2024

HEATHER CROWLEY- POSTING TO NEW POSITIONS THAT WERE ADDED TO THE BUDGETS. YJ GOING TO START TRACKING NARRATIVES OF KIDS BROUGHT TO JUVENILE DETENTION CENTER AND THERE IS A GAP IN PROVIDING INFORMATION ABOUT UNHEALTHY TEENAGE RELATIONSHIPS. TRY AND GET THE MENS GROUPS PRESENT TO JUVENILE JUDGES.

SHANNON BARRY- NOT MANY UPDATES. HIRING CASE MANAGERS. NUMBERS HAVE PASSED PREVIOUS YEARS

SHARYL KATO- PROGRAMS ARE THRIVING. SEEING MORE ADULTS AS SURVIVORS OF SEX TRAFFICKING AND WORKING WITH THEIR CHILDREN. MORE REFERRALS THROUGH RAPID RESPONSE. EARLY CHILDHOOD ZONES ARE SEEING WAITILISTS, FIRST TIME. SPANISH SPEAKING MOMS GROUP IS WEEKLY. WORKING WITH ADULT SURVIVORS OF DV AND SA.

VANESSA STATAM-HIRING 11 SERVICE FACILITATORS AND NEEDING MORE TO MEET THE NEEDS. MULTICULTURAL HEALTH CONFERENCE REGISTRATION IS OPEN

VIRGINIA GITTENS EXCUDER- ALMOST FULLY STAFFED. BUSY. 2 LEGAL ADVOCATS AND FLOODED FOR MOSTLY FAMILY LAW. SUPER GROUPS ARE BACK IN PERSON. MENS SUPPORT GROUP IS COMING BACK IN APRIL.

NELA KALPIC- UPCOMING VIRTUAL CRIME VICTIMS RIGHTS CONFERENCE IN COLLAB WITH WI DEPARTMENT OF JUSTICE APRIL 17 AND 18.

MARLYS HOWE – (ON BEHALF OF AMY BROWN) HAVE 2 LTE POSITIONS IN CRIME RESPONSE SPECIALIST. OUT DOING LAW ENFORCEMENT TRAINING. (JUST TRAINED WAUNAKEE – 1ST TIME IN 23 YEARS)
