Dane County has budgeted State aid funds for transportation service to the elderly and disabled individuals. The proposed transportation projects are derived from the 2024-2028 Coordinated Public Transit-Human Services Transportation Plan for Dane County.

A quorum of the Specialized Transportation Commission may be present but no action will take place.
