Dave Peters discussed sheltering models in other communities. He feels our facilities are overcrowded and can be compared to "warehouses." We need special needs shelters.

John Heimlich commented that he is grateful for services that exist. He supports limits and feels that 1490 Martin Street is an inappropriate location.
