McNamara and Meuer urged the council to establish a subcommittee to develop the proposal for a program. Discussion ensued regarding the experience of other counties, whether an assessment tool may prompt more people to be in jail, and the impact on the budget. The importance of evidence based practice in being competitive for future funding opportunities was noted.
