#### 1. Report of Community Restorative Court Team on Center for Court Innovation Trip

Clark reported on the trip to New York City by a team of county staff, the DA, Supervisor Stubbs, MPD, and community members, to work with the Center for Court Innovation and visit various community justice projects. She presented information about the Red Hook Justice Center, the Harlem Community Court, and the Brownsville Community Justice Center. She discussed the co-location of services at Red Hook, as well as the peacemaking component. At Red Hook, the judge is an advocate for the community. The Harlem Community Court focuses on prisoner re-entry. The Court focuses on procedural justice, and 50% of the staff are former inmates. The role of faith based leaders in community based justice was also key. The Brownsville Community Justice Center is in an area of high poverty and high gun crime. The Center targets a service response to the 17-25 year old cohort.

#### 2. Racial Justice Innovation Project Update

There was a RJIP webinar earlier in the month wherein eligibility requirements for the program were discussed, as well as the possibility of developing a webpage and brochure about the initiative. At the November subcommittee meeting, the project evaluation team from UW Population Health will make a presentation to the subcommittee. Discussion ensued regarding eligibility for the program, with differences between the DA and the Office of Public Defender noted.
