### F. Reports to Committee

#### **1** Community Restorative Court Status Update

The subcommittee discussed the Community Restorative Court. Issues pending resolution include an MOU between the Madison Police Department and the District Attorney's Office, the potential need for a volunteer victim advocate, eligibility criteria for program participation, and the timing and types of cases for a "soft launch". The District Attorney indicated he had a meeting scheduled to hammer out specifics with MPD and program management in the Department of Human Services.

MPD will be training officers in restorative justice.

There was agreement that the target date for a soft launch be in February, but that it was dependent on specifics being clearly worked out.

The Community Restorative Court staff is working on developing a booklet of resources. Edgewood College is developing a monthly newsletter for the Community Restorative Court. Another group will be trained to volunteer with the program later in January.

Discussion ensued regarding grant opportunities. There is a grant through the Wisconsin Department of Corrections due February 12th. The Center for Court Innovations mentioned a large federal Department of Justice grant for which they have nominated Dane County.
