B. Consideration of Minutes

E. Reports to Committee

Community Restorative Court Update

The first restorative court process begins on July 9, 2015. Mike Alvarez discussed the cases that are potential CRC participants, which include: disorderly conduct, disorderly conduct/ theft, simple battery. The demographics of the potential participants are 50% white, 50% African-American.

Chance discussed support of the CRC and two Master level Social Workers that will be providing additional service for the CRC.

Clark discussed ongoing technical assistance from the Center of Court Innovation and suggested we ask them for a site visit in October of 2015. Clark will ask CCI about confidentiality and the media, as media has inquired about attending the call-ins and interviewing participants.

2. Racial Justice Improvement Project

Clark updated the team and notified the group that the final report and evaluation is being completed. RJIP members need to get any comments regarding the report evaluation to Clark prior to 12 noon on June 26, 2015. The "2015 Cultural Context of Corporal Punishment Conference" will be on November 19-20, 2015.
