Benson explained the By Youth For Youth Grants partnership and the current funding situation given the departure of long-term funder Oscar Mayer. At this point, the County and United Way have committed to contributing an additional \$4000 to support the program. Additional City funding is pending. United Way continues to pursue a private sponsor to replace Oscar Mayer. Recruitment for the BYFY committee will commence after school starts. An application will be used this year to give teachers and others a tangible form to share with youth who are interested.
