D. Reports to Committee

1. TAD grant funding

T. Campbell presented – Dane County was awarded funding through the application process

Applied for funds for drug court and deferred prosecution for opiate dependent individuals – applied for \$224,000 and awarded \$214,000 (the only thing that had to be taken out was not being able to go to national conferences with grant money)

Corrigan inquired about the local match

Percent of drug court diversion accounts for 23-24%

Will need to non-competitively re-apply next year

Request was made to move the Diversion Workgroup Report and Municipal Restorative Court Report before the Luminosity Recap.

2. Luminosity recap (PSA tool)

Clark-Bernhardt presented. The Laura and John Arthur Foundation have put information into the public domain. Expect Luminosity to come back to finalize the decision-making framework in which case there would likely be a week long training on the PSA for stakeholders.

They are currently in process to get funds to hire the PSA Assessor.

Discussion ensued regarding what resources will be needed.

J. Bauman presented the workgroups findings

Three major themes of the workgroup's recommendations:

- *How to keep people out of the formal system*
- *How to minimize the amount of time they are in jail*
- *How to keep people from returning to jail once they are released*

The recommendation that received the most votes was the expansion of the community restorative court.

The presentation to PPJ got the ball rolling, but it is really up to others(stakeholders) to figure out what the next steps are.

4. Municipal Court Restorative Justice update

A. Johnson presented. Discussion ensued regarding the pilot which started small has grown to include the entire city of Madison. 72% have successfully completed the program. They are currently looking at a way to get success stories back to officers.

Did get some one time funding that will go away this year – loss of \$150,000, still have \$250,000 available to this initiative.
