Survey was completed by many agencies/programs to collect information – there was a mix as to what type of information was gathered Implementation responsibilities lie with a different group of people – so challenges related to funding will need to be addressed by them Three major themes of the workgroup's recommendations:

- How to keep people out of the formal system
- How to minimize the amount of time they are in jail
- How to keep people from returning to jail once they are released

The recommendation that received the most votes was the expansion of the community restorative court.

Discussion ensued on other initiatives and funding sources that are occurring in other municipalities

Discussion ensued regarding the next steps, although the workgroup did not address them. The CJC or Chair of Public, Protection and Judiciary should review and create next steps.
