Director Livingston reported that enplanements for July were up 11% from the same month last year. Year-to-date there was an 8.6% increase. August enplanements were up nearly 13% and Year-to-date up 9.2%, on par for a record year for Dane County Regional Airport (DCRA). Statistics shared at the Airports Council International (ACI) World Conference that staff recently attended in Montreal, Quebec, showed that DCRA had the second largest increase year-to-date in passenger traffic in the nation among 25 similar-sized airports.

Livingston reminded commissioners that the Noise Abatement Subcommittee was meeting on Monday, October 24, 2016 in the Skuldt Conf. Room at the Airport at 5:30pm.

H. Future Meeting Items and Dates

Discussion ensued, and consensus was reached by commissioners in attendance and staff concurred, to change the Airport Commission meeting day from the third Wednesday of the month to the second Wednesday of the month. The 5:30pm meeting time will remain the same.
