#### D. Presentations

## 1. Re-Entry Court

*L. Weirsmas from DOC along with Community Corrections and the Division of Hearings and Appeals provided a history of the re-entry court concept. Ozanne added information regarding the Harlem example.*

*DOC hopes to start their pilot in Dane County in September. Weirsmas stressed that this is not a formal "court" and that it will utilize administrative law judges.*

*The Public Defender's Office has been involved in shaping this initiative. The goals of the program will be to improve safety and accountability, reduce recidivism, improve compliance, provide treatment and reduce revocations.*

*The team running the pilot will be comprised of Administrative Law Judge, Sally Pederson, a probation and parole agent, a public defender, a case manager and an employment coordinator. Participation in the program will be voluntary. The pilot will begin with revocation cases and focus on those with high risks, Dane County connections and identifiable service needs.*

*The Department has identified service providers who may take cases on referral. Parisi asked if those services are accessible when needed. Corrections indicated that wait lists may exist for some services. DOC identified mentoring as a need.*

*Parisi asked if DOC had approached the Safety and Security Committee that oversees operations of the Courthouse for permission to use space. DOC said they would follow up on that suggestion.*

### 1. Grants

*Clark reviewed three grants.*

- 1. The first pertained to pre-arrest diversions and is focused on behavioral health professionals and law enforcement.*

- 3. The third will focus on implicit bias and racial anxiety training for law enforcement.*
