- *Dane County Demographic Profile – Sharon Lezberg provided a brief overview of the demographic profile for the county that she recently pulled together for the Department's Civil Rights Review that was held in April.*
- *Report on Civil Rights Review – Carrie Edgar provided the Assessment Report and the action plan developed from the Civil Rights Review.*

E. Reports to Committee

- *Youth Governance Program update – Jess Calkins provided an overview of the current happenings of the program. She will be sending out the call for nominations for the next cohort soon. Discussion was held regarding changing the guidebook to limit to 10 -12th graders. A recommendation was made for Calkins to develop a report with how many freshman have applied and how many have been accepted into the program in the past for the committee to report. Discussion was also regarding whether students should be allowed to serve a second year. Nelson recommended that staff develop a set of recommendations for the review of the Handbook and it be provided to members ahead of time. Veldran recommended that an annual review of the handbook be built into the schedule of the Extension Committee. Stubbs requested that exit interview/evaluation summaries be shared with the committee to determine if the program is reaching the identified outcomes. Stubbs suggested the committee may want to consider a joint meeting with the Youth Commission at some point in the future to discuss YGP.*
- *Restructuring of Extension update – Planning continues for the restructuring process. An update will be provided at the February WCA meeting.*
- *Department Head report – Edgar reported that Emily Capicik retired on Jan 3, 2017. An Acct Clerk III position has been posted and hope to do interviews soon. The 4-H Youth Development Educator position has been posted internally within Cooperative Extension and will close on Jan 17th. She requested that one of the committee members participate in the interviews for the Educator position.*
