ADRC Governing Board Chair Frazier reported the November meeting was cancelled due to a lack of quorum. ADRC staff remain inundated with the transitions to Family Care, Partnership, or IRIS for the more than 2,400 individuals in the County's legacy waiver program. The sign-up rate has been slow, with many people choosing to delay completion of the enrollment paperwork until the deadline.
