- 2. Equity and Access Beverly Hutcherson shared that Operation Fresh Start will give away the pollinator seeds at a fundraiser in May. Lynn-Miller shared that the group also reviewed the Marshall Food Access report and discussed the development/adaptation of a standardized survey tool to gather input from community members regarding food access issues.
- 3. Land Access Edgar shared that the work teams will meet on Monday, March 27th at 4:30 pm.
- Madison Food Policy Council George Reistad provided an update on the Madison Food Policy Council committees and programs including: a pollinator GIS project, food procurement efforts, the Double Dollars program, SEED grants were approved last night by the common council 11 projects were funded for a total of \$50,000
- Public Health Madison/Dane County Nick Heckman provided an update on what is happening at the state and federal level regarding budgets and food related projects.
- Dane County UW-Extension report Carrie Edgar shared that Extension will be offering the 21 Day Racial Equity Habit Building Challenge, April 9-29. The Organic Incentive Program has been released to the public. The expansion of the Partner Share program is moving forward.
