*Discussion continued on potential vision components. Schmidt inquired if it is preferred to give the model from previous report as a starting point.*

*Discussion ensued about missing elements, thinking outside of current models, and public engagement timing.  
Question: Does the Committee put forth a model and ask for community voice, or does the community voice start the process?*

*Carter noted that those most impacted, the direct neighbors, will have a strong opinion about the AEC campus.*

*Corrigan noted that the Committee can provide leadership but then genuinely engage the neighborhood and partners.*

*Stubbs requested that the Committee be mindful of asking for input if it is something that cannot be modified/created.*

*Discussion ensued around "good neighbors" - expanding the conversation beyond the campus, Madison, to other areas of the County.*

*Brandon noted the need for aspirational goals and language. Erdman asks how to measure if the plan is visionary? Equity lens utilized? How to measure success?*
