DOWNING proposed a friendly amendment, accepted by KIEFER, to adjust commission membership by: adding Representative, Yahara Pride Farms; one at large farmer; and remove one member of Environment, Agriculture & Natural Resources Committee, bringing the commission membership to 9.

Wisconsin Land & Water Conservation Association

CHENOWETH reported that the Wisconsin Land & Water Conservation Association was currently lobbying the state legislature for additional funding for conservation programs and staff and for additional funding for the UW-Extension system.

STUBBS reported the current statewide staffing changes proposed for UW-Extension do not include changes to the Department Head position of Dane County Extension.

H. Announcements

1.CHENOWETH reported on a tour of installed conservation practices to be hosted by Dane County Land & Water Resources staff for the Wisconsin Land & Water Board on June 6th. Land Conservation Committee members are invited to attend.

2. Callis reported the Land & Water Resources Department has received a grant for approximately \$118,000 from Yahara WINs to extend Harvestable Buffer Agreements in Yahara Watershed. Staff is drafting a resolution for the County Board to accept the funds.

3.DOWNING reported the Dane County Food Council is accepting applications for the Dane County Organic Conversion Incentive Program. The program is designed to provide an incentive for farmers to convert to certified organic practices by providing \$250 per year for up to three years to help offset costs associated with the three year conversion period and organic certification costs. Applications are available on the Dane County Food Council webpage.
