## G. Reports to Commission

### 1. Activity Report

Director Livingston reported that for the month of February, the Airport had a 6.4% increase from the same month, last year for enplanements. March realized a robust increase of nearly 18% for the same month, last year. The first quarter for 2017 was up by 10.6%. The load-factor is high for all of the airlines and overall is at a robust 90%. The parking ramp realized increased revenues over the same period. Positive feedback and discussion ensued.

Deputy Director Jones reported on Air Park Matters and will keep the commission informed of any action they may need to take on such matters.

3. Solar Briefing

Deputy Director Jones briefed the Commission on the bid proposal proccess to hire a consultant regarding the feasibility of potential future solar power collection panels on Airport property.

4. Notification of Cuna Lease Extension

Deputy Director Jones reported that Cuna elected to extend 2 additional years as written in their current hangar lease.

#### 5. Equipment Purchase

Director Livingston introduced Airport Director of Facilities, William LeGore who briefed the commission and staff regarding the 5 new boarding bridges which are scheduled for installation over the remainder of 2017 under the Airport Improvement Plan grants. The first bridge at gate 13 has been completed. Livingston mentioned that the improvements will further enhance the passengers positive experience at the Airport.

6. Airports Council International (ACI) Award - Best Food & Beverage Program - Small Airport

Chair Haight deferred to Jones to announce the recent award she accepted on behalf of the Airport, Airports Council International Award for Best Food and Beverage Progam - Small Airport
