**1. Confidentiality and Recuperative Variances****2. Corporation Counsel Attorney Dyann Hafner**

Attorney Hafner shared background information about the role of the Long Term Support Committee per the Community Options Program Guidelines and efforts that have been made to protect client confidentiality with regard to the Recuperative Variances that are reviewed. She identified possible past concerns in which client identifying information may have been included in the Recuperative Variance requests. To the extent she is able, Atty Dyann will review past Recuperative Variance requests to redact any client identifying information that may have been posted.

It is her recommendation that the committee go into closed session when the Recuperative Variances are reviewed. Doing so will allow full discussion to ensure committee members have all necessary information in making their decisions while also protecting client confidentiality.
