#### G. Reports to Committee

1. Capital City Trail to Glacial Drumlin Connection Project

Parks Planner, Chris James, summarized the upcoming environmental and construction document process to be undertaken by the County's consultant for the four (4)-mile trail segment between I-39/90 east to the Glacial Drumlin trailhead in Cottage Grove. The real estate for this section was secured by the WIsconsin DNR. Trail construction and connection to be completed by July 2021. The City of Madison will complete the linkage from Buckeye Road in east Madison to I-39/90 by the end of 2018.

2. Lower Yahara River Trail Project - Progress Report

Chris James updated the Commission on construction progress including photos. The western section of the trail in Lake Farm Park will be paved in July 2017 with the bridge over the Yahara and the boardwalk east of the trestle completed by August 11th. LUNNEY indicated that planning is underway for a VIP event to celebrate trail completion in mid-September 2017 with the grand opening event scheduled for June 2018.

3. Subcommittee for Review of Boards & Commissions - Park Commission Report, Chair Lunney

RIPP described his participation on the 3-person panel that is reviewing all County subcommittees and commissions to eliminate those that are unnecessary. A meeting of this group was convened on May 17, 2017, and Park Commission Chair LUNNEY attended and provided written remarks in support of the Park Commission.
