## Updates and Action Items for Workgroups

*The full subcommittee discussed the workgroup findings/next steps:*

*System Health - the group will pull SEPSIS literature, plan to bring a draft to the September meeting (August develop draft). The ability to show EMS time saving would assist with showing the need to EMS. Meier will work to pull peds airway and Ketamine for the workgroup to look at in August and report findings in September*

*Education Training - Macha reported the discussion of the workgroup that the agencies could share the refresher training but having each MD do one presentation a year (1 hour lecture). Meier will work with Macha to draft a curriculum proposal for the group to weigh in on and share in September.*

*This workgroup is also discussion additional medications to protocols, the workgroup will share Mount Horebs plan for Nitrous at the next meeting.*

*Community Engagement - Ryan spoke to the Community Medic/EMT legislation. Continues to wait for budget approval at the State but no forseen concerns. the workgroup feels their role will be to guide the county once approval occurs. They also feel data sharing with the hospitals will be critical. Meier and Lehmann shared news of progress between three companies - Imagetrend, Know 2 and Wishin to allow for this ability. Meier will look to have a presentation by these groups at the September meeting.*

*Information Sharing - the workgroup is looking to add an emergent way to communicate to EMS agencies when needed. Many options were discussed. Meier will demonstrate the Dane County Emergency Management process at the next meeting.*
