# Passing of Phil Lewis

LUNNEY commented that he would appreciate the staff investigating professional sources that might be able to edit down the Phil Lewis video originally produced by Rick Eilertson (City of Fitchburg Environmental Engineer) as a memorial to Phil's legacy. Chris James agreed to consider possible contractors, and LUNNEY will seek funding options to defray these production costs.
